# The gift of a **Guide Dog**

Have you ever wondered just how much a Guide Dog can transform someone's life?

Imagine not being able to see your family or friends, and having to rely on other people whenever you wanted to go out? The world could be a very scary place, where even the simplest activity may present as an insurmountable challenge.

When Liz began to lose her sight at the age of 33, it left her feeling anxious, uncertain and alone.

It's only through a generous gift that a supporter left to Guide Dogs NSW/ACT in their Will that Guide Dog Poppi was matched with Liz.

Now with her beloved Poppi by her side, Liz is no longer afraid to leave her house or catch public transport; simple tasks that we all take for granted.

The stories of people like Jo, Liz, Chrissie and Lachlan (find out more about their stories in the enclosed DVD), whose lives have been transformed forever, are just four of the more than 4,000 we encounter every year.

## The costs are great...



Our puppies are bred for the behaviours and temperament needed to become successful Guide Dogs, but first they need to grow up a bit and experience the big wide world.

It takes two years  
and costs **\$50,000 to breed,  
raise and train every Guide Dog.**

So at 8 to 10 weeks, each puppy leaves the Guide Dogs Centre to live with a volunteer puppy raiser until they are 12 to 14 months old.

During this time, the puppy raiser teaches basic obedience skills and introduces the puppy to the sights, sounds and smells it is likely to encounter as a working Guide Dog.

Over five months they work with a specialist Guide Dog Trainer learning to avoid obstacles and hazards, stopping to indicate change of surface such as kerbs and obeying commands. This brings out their natural guiding ability and increases their confidence.

**At about 14 months,** puppies return to the Guide Dogs Centre for their specialised Guide Dog training.

Following graduation, each Guide Dog is carefully matched with their handler. Our skilled Guide Dog Mobility Instructors consider the personality, physicality, age, location and lifestyle of the handler.

Together the handler and Guide Dog will do some post graduate training to complete the **transformation from one person and one dog to a very special Guide Dog partnership based on mutual trust and loyalty.**



## Pets as Therapy dog Kody helps bring Lachlan out of his shell

Not all dogs that undertake training meet the high standards required to become a Guide Dog. They may demonstrate behavioural traits better suited to our Pets as Therapy program. This program makes a huge difference in the lives of people who may be disadvantaged due to illness, disability or isolation.

This is something Janine witnessed first-hand when her son Lachlan, who was born blind, received his special four-legged friend, Kody, from Guide Dogs NSW/ACT.

Janine said Kody had a huge effect on both Lachlan and the family. Pets as Therapy dogs contribute to sensory and physical development and enhance confidence and self esteem. In particular, having Kody has helped Lachlan with his speech and social skills.

“Before we had Kody, Lachlan had limited speech. **Now all he talks about is his dog.**”

Janine applied for a Pets as Therapy dog for Lachlan to help prepare him for the future.

## Including a **life-changing** gift in your Will

A gift in your Will can make a life-long difference to someone who is blind or has sight loss.

There are many ways to include us in your Will and it is advisable to seek legal advice when preparing your Will.

Three of the easiest options to include a gift are:

- **The residue** – a gift of whatever is left after you have taken care of your loved ones
- **A percentage** – often regarded as one of the most flexible ways to give, as the amount adjusts and accounts for inflation or changes to your total assets.
- **Fixed amount** – a specific sum which may need to be changed over the years to account for inflation and changes to your circumstances.

It is essential that Guide Dogs NSW/ACT is correctly named in your Will. The form of wording overleaf is provided for you to consider and take along to your solicitor. If you have any questions please call **Sally Biles on (02) 9412 9319**.
